Section 4 First Aid Measures

INGESTION: Call physician or Poison Control Center immediately. Induce vomiting only if advised by appropriate medical personnel. Never give anything by mouth to an unconscious person.

INHALATION: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention. May cause respiratory tract irritation.

EYE CONTACT: Check for and remove contact lenses. Flush thoroughly with water for at least 15 minutes, lifting upper and lower eyelids occasionally. Get immediate medical attention.

SKIN ABSORPTION: Remove contaminated clothing. Flush thoroughly with mild soap and water. If irritation occurs, get medical attention.

Section 5 Fire Fighting Measures

Suitable Extinguishing Media: Use extinguishing agent suitable for type of surrounding fire.

Protective Actions for Fire-fighters: In fire conditions, wear a NIOSH/MSHA-approved self-contained breathing apparatus and full protective gear. Use water spray to keep fire-exposed containers cool.

Specific Hazards: During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Yields flammable hydrogen sulfide on contact with acids and sulfur dioxide when burning. Finely divided ferrous sulfide may form explosive mixtures with air. Hydrogen sulfide and sulfur dioxide are both extremely toxic gases.

Section 6 Accidental Release Measures

Personal Precautions: Evacuate personnel to safe area. Use proper personal protective equipment as indicated in Section 8. Provide adequate ventilation.

Environmental Precautions: Avoid runoff into storm sewers and ditches which lead to waterways.

Containment and Cleanup: Recover for reuse if not contaminated. Sweep or vacuum up and place in a suitable container for proper disposal. Wash spill area with soap and water.

Precautions for Safe Handling: Read label on container before using. Do not wear contact lenses when working with chemicals. Keep out of reach of children. Avoid contact with eyes, skin and clothing. Do not inhale dusts. Use with adequate ventilation. Avoid ingestion. Wash thoroughly after handling. Remove and wash clothing before reuse.

Conditions for Safe Storage: Store in a cool, dry, well-ventilated area away from incompatible substances. Do not store near acids, moisture and air.
